The 'local Green Belt Review' (para 5.40, p 62) was a search for housing sites in the Vale's portion of the Oxford Green Belt. In paragraph 1.21, pages 16-17 of the Local Plan, Strategic Sites & Policies document, the Council sets out how the Vale Council will work with the County Council and the other Oxfordshire District Councils to complete an Oxfordshire-wide Strategic Green Belt review. I believe that no land should be removed from the Vale's portion of the Green Belt and no strategic sites should be allocated until this comprehensive review is completed.

Delete all references to the 'local Green Belt Review'.
