THE VILLAGE OF SHIPPON IS WITHIN GREEN BELT FOR THE VERY GOOD REASON THAT IT IS AND SHOULD REMAIN SEPARATE FROM ABINGDON TOWN AND HOUSEBUILDING DEVELOPMENT EXTENSIONS THEREOF THUS PRESERVING ITS HISTORICAL RURAL CHARACTER.

THE REMOVAL OF GREEN BELT PROTECTION TO THE VILLAGE WOULD HERALD WIDESCALE BUILDING DEVELOPMENT IN THE VILLAGE WHICH WOULD COMPLETELY ALTER THE RURAL CHARACTER OF THE VILLAGE. THE EXISTING ROAD NETWORK INFRASTRUCTURE WOULD STRUGGLE TO COPE WITH ANY INCREASED TRAFFIC SUFFERING AS IT ALREADY DOES WITH THE USE OF BARROW ROAD THROUGH SHIPPON AS A "RAT-RUN" FOR VEHICLES WHO WISH TO AVOID THE LIKELY QUEUING OF TRAFFIC PROCEEDING THROUGH THE OUTSKIRTS OF ABINGDON.

THE PROPOSED HOUSING DEVELOPMENT ON THE MOD AIRFIELD SITE WILL ALREADY IMPACT ON THE VILLAGE OF SHIPPON AND SHOULD NOT BE COMPOUNDED BY REMOVAL OF GREEN BELT PROTECTION FOR THE VILLAGE AND THE RESIDENTS WHO HAVE CHOSEN TO LIVE THERE IN A QUIETER RURAL ATMOSPHERE COMPARED TO LIVING IN A TOWN.
