While the Local Plan part 2 provides policies that address the needs of new developments it fails to provide solutions to the impact of traffic as a result of the proposed sites on existing settlements within the Vale.

Specifically, there are concerns about the traffic volume through Appleton village that runs parallel to the A420 (from the A415 to Cumnor village), as a result of the substantial development at the allocated site east of Kingston Bagpuize at Fyfield.

The increased volume/capacity ratio of traffic along the A420 corridor predicted by the modelling assessment in the Evaluation of Transport Impacts (ETI) – Stage 2, at points both east and west of Appleton is likely to increase traffic flow through the village as an alternative route to the A420. This increased traffic flow is predicted in the ETI- Stage 2 for option 1, 2, 3 and the mitigation scenario (see ETI – Stage 2 figures 7, 8, 11, 12, 15, 16, 22 & 23).

These will have several impacts for Appleton village and the wider parish. There are safety concerns for pedestrians particularly schoolchildren during the peak morning hours with Appleton being a rural village without the infrastructure (such as pedestrian crossings) to cope with an increase in traffic flow. There are concerns over possible decline in air quality in the village due to congestion on the narrow roads producing an increase in airborne particulate matter and nitrogen dioxide (in contradiction to Development Policy 26). There are safety concerns for cyclists on the narrow rural roads with nation speed limits.

The Local Plan part 2 does acknowledge the potential increase in traffic volume along the A420 corridor but does not offer any solid solutions other than an improved public transport service from the new allocated sites. This is unlikely to be sufficient to deter drivers from the A415 rerouting through Appleton to avoid the potential congestion on the A420 between Southmoor and Botley Interchange.

Modifications to the Local Plan part 2 will be required to address the impact of increased traffic on major roads, such as the A420, and provide policies that will ensure proposals for development support existing settlements affected by the subsequent traffic increase to put in place measures that would ensure the prevention of rerouting traffic through villages with rural roads lacking infrastructure.

The Local Plan part 2 could ensure that proposals that result in the increase in traffic along the A420 corridor have in place measures to improve the A420 by widening the carriageways at the points at which the increased volume/capacity ratio of traffic is increased (see ETI – Stage 2), thus decreasing the risk of congestion and reducing the likelihood of traffic rerouting through rural villages.

In the case of Appleton, these measures could be in the form of traffic calming measures on Netherton Road at the junction of the A415 and from the junction of Abingdon Road and Appleton Road in Cumnor as a deterrent to divert through Appleton. In addition, providing funds to re-instate the bus service through Appleton would contribute to reduce the number of car journeys from Appleton residents.
