Shippon is a small historic village that can trace its roots back to thr Doomsday Book. Today Shippon is firmly located inside the Green Belt. This has provided much needed protection from inappropriate development. I have lived in Shippon for over 35 years and in that time the village has not materially changed it's size or scale. The village and its residents have happily coexisted with our larger neighbours, Abingdon Airfield/Dalton Barracks and Abingdon. Being firmly positioned inside the Green Belt, this small (some would say tiny) village has felt safe and secure.

The LLP1 document made it clear that Shippon would remain in the Green Belt. This was welcomed by the residents, 84% of whom, in a survey conducted by the Parish, wished and wanted Shippon to remain in the Green Belt. Now with the publication of LLP2, the planners are proposing that Shippon and the new, 1200 dwelling development on Dalton Barracks should form an inset and excluded from the Green Belt. This despite the massive reduction. In the planned Dalton Barracks development from 4500 to 1200. Dwellings. If this were to be agreed, Shippon would have no statutory protection against development. This proposed change defies logic and flies in the face of NPPF 133 which speaks to urban sprawl and makes clear the perminance and openness of Green Belt. NPPF 143 says inappropriate development is harmful to Green Belt and should not be approved except in very special circumstances. Given the reduction of 3300 dwellings and the large volume of land on the Dalton Barracks site, there are absolutely no special circumstances and absolutely no necessity to remove Shippon from the Green Belt.

There are particular words and phrases in LLP2 which gives me great concern. These are

You say THE HISTORIC CENTRE OF SHIPPON LIES TO THE SOUTH OF DALTON BARRACKS. IT REMAINS RELATIVELY INTACT AND STILL SURVIVES AS A HISTORIC VILLAGE WITH A RURAL APPROACH FROM THE WEST ALONG BARROW ROAD.

DEVELOPMENT ON THE SOUTHERN PART OF THE SITE SHOULD RESPECT THE HISTORIC CHARACTER OF SHIPPON AND ITS RURAL APPROACH.

What exactly do you mean by RESPECT? How do you propose to measure, monitor and control?

Page 11 section 2.74

Shippon AND THE EXISTING AND PROPOSED DEVELOPMENT AT DALTON BARRACKS is inset to the Green Belt as it will form an integrated and continuous settlement ALBEIT PROTECTING AS FAR AS POSSIBLE THE EXISTING CHARACTER OF SHIPPON with Dalton Barracks.

What exactly do you mean by AS FAR AS IS POSSIBLE? How do you propose to measure, monitor and control?

I want to make clear that I have no objection to the development of 1200 dwellings on Dalton Barracks. Equally I have no objection to a future development of a so called Garden Village on Dalton Barracks. It's a huge site and there is plenty of capacity to develop a new Garden Village with a open Green Belt land between it and the small, historic village of Shippon.

The decisions you make should be based on the very real need to provide well planned and well built additional, affordable housing whilst respecting the unique historic significance of an existing community, safely situated inside the protection of the Green Belt. If you take away that protection, you will forever alter the character of Shippon and lay it open to inappropriate development.
