"The site is removed from the Oxford Green Belt in accordance with Core Policy 13a. The site area, however contains an area of land that will remain within the Oxford Green Belt and any development on this area will be limited to Green Belt compatible development. This area will include an area of local green space (in accordance with the principles set out within government guidance notes) located on the western and northern sides of the site should be designated within the overall masterplan for the site and retained as such in perpetuity."
