Having attended the public meeting on the Local Plan Part 2 held in Faringdon Corn Exchange on 14th November 2017, it appears that the Local Plan does not comply with the duty to cooperate. When issues were raised regarding traffic, school places and health services relating to the Kingston Bagpuize development the audience were repeatedly told that this was not a district council issue. There were no representatives of the county council present to comment.

Yes

I am concerned that the lack of cooperation between the district and county councils and OCCG may mean that critical infrastructure will not be put in place. In particular new residents will be expected to register at the White Horse Medical Practice and to send their children to Faringdon Community College, both of which are close to capacity.
