The Project feels that the importance of these water courses is undermined by: 3.244 The extent of the buffer is dependent on the size and nature of the development, but it should be a minimum of 10 metres wide, measured from the top of each bank' We would be urge that the importance of the watercourse in particular the chalk streams is enshrined such that the chalk stream and habitat is protected despite the size and the nature of the development. We would go further to propose a 50m buffer strip (where possible) where development occurs next to a chalk stream to maintain a corridor within which natural processes can occur and natural habitat can be maintained.
