Traffic: the plan is based on historical and out of date information. It neither takes into account the extent of recent developments along the A420, nor the effect of current developments. As a resident of Fyfield I carried out a survey of traffic which confirms the road is already overloaded. With this development it can only worsen. The introduction of another roundabout will slow traffic causing further queues, more pollution and far longer journey times.
