The estimate of 23000 new jobs, based on the SHMA, has led to a requirement for 20560 additional homes in the Vales by 2031. To provide for this large number of homes, several sites in areas with questionable sustainability have been included in the plan. The SHMA estimates are based on a number of assumptions that have been challenged by the Oxfordshire CPRE and others. Considering historic rates of growth in jobs and houses makes it appear highly unlikely that the estimated high rates of increase in jobs will be achieved by 2031. If they are built, it is likely that large numbers of houses will be bought by people wishing to commute to Oxford or London, the exact opposite of the intention to reinforce sustainability through enabling people to live close to their place of work.
