Attention Chris Randall and Andrew Maxstead.

I was kindly given permission to submit my objections to the Local Plan Part One: Strategic Sites and Policies, provided I submitted it by Christmas Eve.

Being acutely aware that it would be a lot of extra work for you to assemble the corrections into the original submission, I did the assembly for you, and this is in

I am sending this message just to summarise the situation because I do not think I correctly entitled the messages B and C in the subject line. > Following your generous agreement to the submission of comments on the Local Plan later than 19th December, the official deadline, due to my serious illness, I have struggled with the pain, which has necessitated hefty doses of drugs which render me tired, so eventually I am writing this in the small hours of the morning of 24 th December and am really only capable of the most rudimentary response.

> As I described to Chris last week, I have an extensive background in the area, having lived in Abingdon for 43 years, and worked in the Abingdon Area as a scientist at Culham laboratory and at the Joint European Torus (the JET Project under Euratom Management) and as an Associate Lecturer with the Open University, teaching at sites in Abingdon, Oxford, Witney, Aylesbury, Banbury, Newbury, Reading, Bletchley, Milton Keynes, Henley and High Wycombe.

> But now I must write my objections, which will be on important points but in less detail than I would have wished and with very much less in the way of references than desired. I hope that in the circumstances that my submission will be treated as a valid one. If requested to do so I would be willing to amplify and/or annotate any part of my submission if it is regarded as insufficiently clear.

> My submission is in an accompanying email, submitted at 1200 hours this day.  
>  
> In that submission I undertook to provide spelling and syntax corrections and corrections of howlers such as text rewriting by the computer, but not to make any additions, and also to provide a reference of the URL to the eventual YouTube posting of the pictures of the ancient woodland etc., which will also be posted on the Long Furlong Community Centre website as soon as I learn how to edit my film and post it as stated. Hopefully that will be ready immediately after Christmas as the footage is complete already.
