The Plan identifies four development sites in the Oxford Green Belt to accommodate 1,510 dwellings. A further 11 sites in the Green Belt are proposed to be removed. This is based on the Vale Council's so called "local Green Belt Review", it was no such thing, it was a search for housing sites in the Vale's portion of the Oxford Green Belt. No allocation of sites in Vale's portion of the Oxford Green Belt should be made until a full joint review of the entirety of the Green Belt is completed by all five Oxfordshire Districts and the County Council
