It will drastically increase demand on local infrastructure, including schools, recreation facilities & GP and dental surgeries, and there is inadequate space within the proposed development site for these

amenities to be built. In addition, more demand will be placed on parking in Abingdon town centre and at local supermarkets, which do not have the capacity to cope with new developments in both the North & South of Abingdon.
