The additional housing planned for Faringdon will overload single carriageway sections of the A420, between Faringdon and Oxford, which are already dangerously busy. The current local plan does not specify improvements along this route and I therefore do not consider it to be strategically effective in dealing with the inevitable increase of traffic on this route.

Inclusion of a Buckland Bypass in the Local Plan would eliminate one of these dangerously busy sections of road. A section of dual carriageway extending from the Buckland turning (Buckland Road) on the A420, to run south of Pusey Common Wood, rejoining the A420 just after the B4508 junction would cut out this dangerously overloaded section of road and provide uninterrupted dual carriageway from Buckland through to Fyfield.
