I believe the Local Plan is not legally compliant as it is not consistent with the Vale's principles and policies nor those set out in the National Planning Policy Framework.

For example there was no real consultation on whether this particular site was suitable, there was no public meeting.

The Vale states it Promotes thriving villages and rural communities whilst safeguarding the countryside and village character.

It also states it is identifying appropriate housing requirements for Larger Villages and so helping to maintain their vitality with jobs being focused in these settlements.

The proposed site South of East Hanney with the prospect of 200 extra houses being built there, is in no way fulfilling any of these statements.

It is definitely not safeguarding this precious piece of countryside or the character of our village. 200 houses are almost doubling the size of our village without the infrastructure to support this.

Where is the proof we need all these houses, where are all the people coming from to fill this number of houses in East Hanney. The village had a survey last year and it found there were no requirements for more housing.

Also providing so many more affordable housing in villages where the need is not proven is frustrating, it will mean people will have to come from outside the area to fill these houses. This is likely to change the character of our village forever.

There are certainly not enough jobs locally to satisfy the number of people who would be living in the proposed 200 houses in this rural community, therefore even more car travel .

The local primary school is full with no plans to increase the size of the building so young children will need to be driven out of the village to other schools. This does not encourage integration into the community in any way.

The infrastructure needs to be in place first including roads, schools, health centres and transport, the A338 is very busy and will become even busier with so many more houses being built down the road in Wantage and Grove.

East Hanney does not require this number of houses, especially when there are other Larger Villages in the Vale of the White Horse much more able to accommodate this number of houses.

Fewer houses where they can be better integrated within the village and the occupants of these houses better able to become part of the community would be much more sensible.
