The sewage treatment works at Grove, currently serving Wantage, Grove and both East and West Hanney, is already at capacity and there have been occasions where sewage backflushes through the drains, unpleasant at best and a potential health risk. Provision needs to be made for upgrading the sewage works before any further building developments take place, including Grove and Wantage, as well as this proposed site south of East Hanney. There appears to be no proposal or plans to address this issue, another point making the plans unsound.
