As currently drafted, paragraphs 4.7-4.15 fail to reflect the role that windfalls in settlements ranked below the four tiers of the settlement hierarchy (para 4.7) have played in the past in maintaining the supply of housing in the Vale.							
To exclude the lowest order settlements and rural communities from the hierarchy is inconsistent with paragraphs 54-55 of the NPPF and demonstrates that the Plan has not been positively prepared in that it fails to plan for the objectively assessed needs of the area (NPPF paras 14 & 157).							
Consequently the Plan is not justified and is inconsistent with national policy and it is thus unsound.

By making the following changes, the Plan will be sound in that it will reflect a more holistic approach to supporting the rural communities in the Vale without excluding certain villages and rural communities from benefiting from anything other than affordable housing. This will accord with the NPPF and it will demonstrate that the Plan has been positively prepared.

The four tiers of the hierarchy (paragraph 4.7) should be expanded to refer to the lowest order rural communities and settlements as a fifth tier.

Please note your representation should cover succinctly all the information, evidence and supporting information necessary to support/justify the representation and the suggested modification, as there will not normally be a subsequent opportunity to make further representations based on the original representation at publication stage.
