The three sites proposed in the wantage and grove area total 4750 new houses. The roads out of Wantage (A338 North) and (A417 East) are already beyond capacity at peak times. The adjustments proposed to the junctions at Frilford (A338) and rowstock /featherbed Lane may well help the existing traffic but would be inadequate for the proposed increases particularly at rowstock with increases from more than one direction. There is no mention of the station at Grove being open in the view of how the area will look in 2031. This shows how likely this is to happen in reality. The station could take some traffic from both routes above.
