The adoption of a site between the Oxford Road and A420 as a strategic site (No 7) for 280 dwellings fails to meet the sustainability test. The plan provides no additional local infrastructure, particularly in relation to employment, transport or medical facilities. Many of the proposed houses will be remote from village services and bus stops which can only be accessed by crossing the busy A415. This will generate additional car journeys to visit the PO, shops, Primary School, and Village Hall. Given the dearth of employment opportunities within the village, the additional traffic on the A420 from this site and elsewhere along the Swindon-Oxford corridor will bring traffic on this trunk road to a halt with increasing frequency. The village lacks any medical facilities and the future of the Children's Centre is in doubt.

6.
