The Vale of White Horse District Council undertook a consultation on Part 1 of the Draft Local Plan 2031 in the Spring of 2014. In that draft, a strategic allocation of 200 houses was proposed for a site to the 'East of East Hanney'. When the next draft of the Plan appeared at the beginning of November 2014 for the current consultation, it proposed a completely different 'South of East Hanney' site. There has been no consultation with the community on this revised proposal and no reasons have been given for the change. We know from the recent community ballot that there is overwhelming objection to the newly proposed site. Accordingly, since the proposals have been made without proper consultation, the Plan is unsound in respect of the South of East Hanney strategic allocation.
