East Hanney has been included in Abingdon on Thames and Oxford Fringe Sub areas. The residents of East Hanney use facilities in Wantage and grove as they are the closest facilities to East Hanney and the majority of children attend secondary school in Wantage NOT abingdon, and residents are registered

with GP's in Wantage and Grove. Therefore any proposed infrastructure development in this Sub Category Area (Abingdon and Oxford fringe) will not benefit Hanney and there is no reference to how developments in Wantage and grove will affect East Hanney or how access to facilities in Wantage and Grove will be impacted by these developments on East Hanney Residents therefore it is not sound and has not been prepared positively.
