I am objecting to the 5 sites around Cumnor Village that the Vale proposes to remove from the Green Belt. The South Cumnor site (numbers 6 and 24) has already been deemed unsuitable for housing in a recent review, so I fail to see why it is necessary to remove it from the Green belt unless there is a hidden agenda to build regardless of its unsuitability as already judged by the Vale. Sites 4 and 5 are also inappropriate as they lie in the Cumnor Conservation area. What is the point of a conservation area if it is not respected?

Government Planning Policy stated that land should only be removed from the Green Belt 'in exceptional circumstances' and stated that 'unmet housing need " is not an exceptional circumstance. Large housing development in and around the small village will destroy the site and character of the village, lose the barrier to urban spread and harm to the local area will greatly outweigh housing need.

There is no evidence that building homes in the area will meet unmet need, as developers do not sell these homes at a low market price to ensure they are affordable. The evidence for this lies in the Timbmet development on Cumnor Hill. Removing these sites from Green Belt will expose them to the risk of speculative development and there is only one group that will benefit from that-the developers.

The village has already been judged unsuitable for further housing by the Vale as the roads are too narrow for extra traffic and would put local schoolchildren at risk as the main one way system passes the school gates.
