Page 37 defines 'Larger Villages' as being "settlements with a more limited range of employment, services and facilities. Unallocated development will be limited to providing for local needs and to support employment, services and facilities within local communities". Harwell is defined as a Large Village, despite the fact that the level of services and facilities are of a low level, more typical of a 'Smaller Village'. There are only three shops and one pub in the village, which provide employment for a very limited number of people. It appears that the assessment of a large or small village and the implications for acceptable development are based on the population of Harwell and not the definitions within the Plan. (For the sake of clarity, it should be noted that the Plan makes a clear distinction between Harwell Village and Harwell Campus and the employment opportunities afforded by the Campus should not be considered in the housing demand for the Village.)

There are no provisions for additional employment opportunities within Harwell and the additional houses will merely provide accommodation for those commuting to jobs in Science Vale, Harwell Campus, Didcot, London and further afield; contrary to the objectives and provisions of the Plan. This will, in turn, add to the already overstretched traffic conditions in the area; especially the A417 and B4493.
