South Oxfordshire District Council response to Vale of White Horse Local Plan 2031 Publication Version November 2014

Thank you for consulting this council on Vale of White Horse Local Plan 2031. South Oxfordshire District Council compliments the Vale of the White Horse District Council on their Local Plan and in general supports the polices and proposals in the plan. This council also confirms that both councils have a very positive working relationship and that the Vale of White Horse District Council has fully complied with the Duty to Cooperate with this council during the preparation of the plan. We are pleased that the plan demonstrates that the council can fully meet its very challenging objectively assessed housing needs and recognise that this has involved some particularly difficult decisions.

We have the following comments on the plan, we do not believe that these issues will make the plan unsound, rather it is hoped they will make the plan clearer.

reference	Comment on Vale Local Plan 2031
	General
	We are satisfied that the two councils have worked together fully under the 'Duty to Cooperate'. However, we think that the initial chapters could better reflect this cooperation if they referred to other partners, such as South Oxfordshire, rather than just the Vale. The need to work with others is acknowledged in the sub-area strategy chapters it would be good if this were also acknowledged earlier on. More specific examples are raised below.
P20	Overview
P75	Para 4 – This overview implies that Science Vale is only concerned with employment. It would be helpful to refer to the Science Vale area stretching across parts of both Vale and South and its mission to provide employment and housing opportunities, to be an attractive and thriving place, to attract infrastructure and investment





2.12	It would be helpful to mention the proximity of other stations,
	particularly Oxford, Didcot and Swindon which give direct access to the
	mainline network.
2.12	Supporting sustainable travel 4 bullet
	With partners supporting improvements.
	A number of these improvements will need the close cooperation of
	SODC and OCC to implement this should be acknowledged.
2.15	Protecting water resources – It may be helpful to acknowledge that this is an area of water stress, if the water cycle study confirms this.
	Protecting biodiversity - This section should acknowledge the need to
	work with neighbours, particularly to link key wildlife habitats and in
	protecting designated sites close to the district boundary.
P40	Housing supply ring fence
	SODC is pleased to see a ring fence approach is proposed for housing
	in Science Vale and strongly supports this proposal. It complements
	the approach taken in South Oxfordshire and will help ensure that the
	investment required is available for the provision of infrastructure and
	services for the high levels of growth in Science Vale. The promotion
	of a step change in the provision of housing, jobs, and infrastructure
	and services has been a long held ambition of both authorities and

P63	Green Belt
	A Green Belt boundary can only be amended through a local plan.

CP12 CP17/18	One of the schemes listed in CP17 the Harwell Strategic Link Road and Southern Didcot Bypass appears to include land in South Oxfordshire policy CP18 cannot safeguard land in South Oxfordshire. The wording needs to be adapted to reflect this Two road schemes one in CP12 (the South Abingdon Bypass) and one in CP17 (the link between the A415 east of Abingdon and the A4130 north of Didcot) have been recently introduced and South Oxfordshire has not had the opportunity to consult on or formally consider these. This will be done through the South Oxfordshire Local Plan 2031. Whilst this Council realises that there is often serious congestion in this area and that solutions need to be found we have some concern about the potential impact of these proposals in South Oxfordshire and therefore reserve judgement on these schemes .
	Sustainability appraisal
12.3.14 – 12.3.16	These paragraphs suggest that sites have been released within the Green Belt whereas the Local Plan indicates that there are areas of the GB which no longer meet the purposes of the GB and the boundary has therefore been changed to remove those areas of land. None of the proposed sites are therefore in the GB as amended or proposed to be amended with the exception of the land north of Abingdon. (see comments above)
