- The level of housing need identified for the city of Oxford is not going to be met within the city's administrative boundary. This point has been acknowledged by the City Council.
- The second paragraph of Core Policy 2 suggests that Oxford City "may" not be able to accommodate the whole of its new housing requirement for the 2011/2031 period within its administrative boundary.
- The Policy should acknowledge that Oxford "will" not be able to accommodate the whole of its new housing requirement. The local plan should acknowledge this.
- The Plan identifies an overall housing requirement of 20,560 for the period 2011/2031 and seeks to meet the full objectively assessed needs for the District Council itself. On the basis that the City will not be able to meet all of its needs, a contingency reserve of at least 10% should be planned for in the plan as reserved sites (either within or beyond the green belt).
- The principle of these contingency sites can be established in the Part 1 Plan and either be identified in it or left to a Part 2 local plan or a partial review. The trigger for the release of these contingency sites can be the acknowledgement of the Oxford City not meeting its needs. This approach will enable the plan to start to meet a portion of these unmet needs as early as possible. Such a change will make the Local Plan more legally compliant, sound and comply with the duty to cooperate.
- 6. - In the second paragraph after the words Oxford City delete "may" and insert "will" instead.
- At the end of the fifth paragraph add "in the meantime this plan establishes the principle of contingencies reserve sites being identified through the part 2 Local Plan or through adopted neighbourhood development plans. No dwelling completions will occur on any contingency reserve sites unless one of the following applies:
- 1- The Council accepts that the overall dwelling requirement for 20,560 net additional dwellings within the district between April 2011 to March 2031 is unlikely to be achieved, it will the identify for development a site or sites from the contingency reserve sites; or
- 2- The Council accepts that there is a deficit in the rolling 5 year of housing land, it will then identify for development a site or sites form the contingency reserve sites; or
- 3- The Adoption of the Oxford City Local Plan confirms that it is not able to accommodate the whole of its new housing requirement for the 2011/2031 period within its administrative boundary then the Council will identify a site or sites from the list of contingency reserve sites for immediate release.
