Appendix 15 of the Sustainability Appraisal concludes that there is no clear preference between the particular strategies. It concludes that higher levels of housing could potentially be more sustainable, but in this case the higher percentage of housing outside the larger urban areas in Option G would lead to a less sustainable option.

The conclusion is qualified by the need to detailed transport assessment of the options. Given that 7,000 extra dwellings in the Preferred Option G would generate c. 50,000 trips per day, based a trip generation rate of 7 trips per dwelling per day, it is difficult to see how significantly higher traffic generation by car could be mitigated by design or development management. There appears to be no sensitivity testing of a "what if" scenario if levels of homes and jobs do not rise above those in Options A, C, D, & E, based on the RSS.
