Sites around Cumnor have been marked for removal of green belt status even though earlier review stated that the land surrounding Cumnor was not suitable for development. Removing greenbelt status serves no purpose other than to make an easier future pathway to development. The greenbelt status of the land around Cumnor should remain.

Of particular concern, site 24 is a parcel of land on crest of hill surrounded on 3 sides by open countryside. Only the shorter side is adjacent to existing dwelling and road so the land does not represent an area enclosed by existing dwellings. Any future development would have a high visible impact due to location and geography and divide country side impacting habitat significantly

The area itself if highly valued by the community for unbroken views across countryside to Wytham woods and used by many. Rather than removal of greenbelt status it would actually be suitable for further protection

In addition it is high quality farm land upon which any development should be avoided
