Planning consultation: Botley Centre SPD – SA Scoping Report

Thank you for your consultation on the above dated 17 June 2015 which was received by Natural England on the same date.

Natural England is a non-departmental public body. Our statutory purpose is to ensure that the natural environment is conserved, enhanced, and managed for the benefit of present and future generations, thereby contributing to sustainable development.

CONSERVATION OF HABITATS AND SPECIES REGULATIONS 2010, AS AMENDED WILDLIFE AND COUNTRYSIDE ACT 1981 (AS AMENDED) SCHEDULE 2, THE NEIGHBOURHOOD PLANNING (GENERAL) REGULATIONS 2012 THE ENVIRONMENTAL ASSESSMENT OF PLANS AND PROGRAMMES REGULATIONS 2004

Natural England has the following comments to make on the Scoping Report for the Sustainability Appraisal:

In paragraph 3.27 it states that Oxford Meadows is a SSSI. Oxford Meadows is actually the Special Area for Conservation SAC, part of which includes the Port Meadow with Wolvercote Common and Green SSSI.

Under 3.35 the opportunities for Botley Centre are listed. Natural England would advise that there is a huge opportunity to fit Sustainable Urban Drainage Systems (SUDS) to both new and existing development within the area. This would help reduce the risk of surface flooding in extreme weather conditions, by holding back the rainwater, as well as improving the attractiveness of the local environment, reduce the urban island heat effect, as well as being beneficial for biodiversity. An example of this being used successfully in an urban area is the Lost Effra project run by the London Wildlife Trust: http://www.wildlondon.org.uk/lost-effra-project

Sustainability Objective 7 has the text 'protection and improvement of biodiversity, particularly Special Area of Conservation' struck through. However as explained above the Oxford Meadows is actually an SAC, as well as a SSSI.
