We believe this proposed development is unsound because it is not consistent with the National Planning Policy Framework in respect of sustainability, historic heritage or land use and is not justified because the evidence base for the Fyfield site is seriously flawed particularly as the transport infrastructure is inadequate. We do not believe the impact of additional traffic from the proposed site has been taken into proper consideration. The A420 is already very busy at the morning and evening peaks and exiting from Fyfield to go east is very precarious. To go west at these peak times is a nonstarter. The proposed building of between 600 - 700 houses on the site can only be a dormitory – commuter development since there is not employment locally or within easy public transport distance. Therefore this proposed development on top of the existing sites already being built in the Kingston Bagpuize - Southmoor area will put greater pressure on a road already operating at over capacity and will result in further air, light and noise pollution. The suggestion of an additional roundabout linked to the site will result in further tailbacks and congestion on the A420. The existing over capacity and "slow - running" of the A420 already gives rise, particularly at morning peak times of "rat running" through Fyfield and Netherton. Allowing this development would only result in an increase in this traffic on very narrow roads with sharp bends. Accidents and possible injuries will result. Additionally, my wife who uses public transport has to take her life in her hands when she crosses the A420 to catch the bus going west. Increase in traffic from the proposed site will obviously add further to this very dangerous situation.
