Housing needs have been complied by a consultancy firm which in turn have carried out works for the VOWC therefore I believe there is a conflict of interest between both parties and therefore voiding the legality of the whole plan

The whole plan sits on the local infrastructure being able to maintain the increased housing and also the environmental impact the amount of housing would have on the area , in particular, the village of Shippon. It is also evident that at no point has the identity of Shippon village been kept in the future plans of the area and the removal of green belt land around the village

Through all the consultation meetings that have been held regarding the local plan there has been no positive steps by the VOWHC to support the local residents of the effected areas and at all times the plans appear to be a DONE DEAL even before anyone has had a chance to object making it also appear that no matter what objections are made at no point is the plan going to change. This cannot be a democratic way of approving plans that will effect a lot of voters and tax payers

The amount of green belt land to be removed needs reducing to safe guard the identity of wootton and more importantly Shippon as continuing villages with shippon village dating before the doomsday book of 1086.

No consideration has been heard or seen to be heard from sitting residents of the surrounding villages that would be greatly affected by the plan as it sits being approved

The legality of the plan would be made if a new fully independent survey was carried out suggest real housing figures and this number used for a smaller and less impactive number of housing to be allowed to be built increasing green belt areas which exist at present

The local plan can only be a sound plan if all infrastructure can be put in place limiting the impact on the local residents including not only the road systems but looking at the future plans for park and ride and highways which , as knowing the area for many years, will not be improved by building additional roadways and bus lanes as the amount of traffic as it stands now is to great for the road systems including the A34.
