The proposed Park and Ride at Loge Hill is not in the most suitable place. If there is to be such large development at Dalton Barracks. It would be better to have the Park and Ride at the Marcham interchange instead. This would have the advantage of not needing the proposed bus & cycle route linking the Dalton Barracks site to the Lodge Hill P&R – a route which cuts across green belt farmland in a way that would make the fields difficult to farm, and which would have adverse effects on Sunningwell. A P&R at the Marcham interchange would be better as it would take northbound traffic to Oxford off the A34 sooner. North Abingdon is already well provided with buses that run up the A34 (X3, X13, X2, S8) so a P&R at Lodge Hill would, if anything, make journeys slower due to the extra stop at the P&R.
