## LEGALLY COMPLIANT.

The Plan involves changes that will impact on every resident of Shippon yet there have been no mail shots resulting in the majority of residents being totally unaware of theLocal Plan.

Most of the information is in a document on the website which is extremely difficult to access and navigate assuming you have a computer.

There was a Public Meeting in Abingdon which was the worst Presentation I have ever attended. The Council team turned up moments before the meeting without any preparation to find the sound system

was not working. When they managed to get it working it was through a microphone fixed to a bench which made speaking almost impossible. There was no means for the public to speak from the floor other than by shouting ( no roving mike ).

Copies of this form for the public to respond by post which should have been available at the meeting had not been brought.

I consider this failure to consult with the puplic invalidates the whole plan.

SOUND.

I cant find any details in the plan of any infrastructure to support road access through SHIPPON VILLAGE which at the moment is overloaded with traffic. SHIPPON VILLAGE has no recreation areas or Village Hall yet it will double in size under the proposed plan without any mention of improved facilities

## DUTY TO COOPERATE.

In spite of objections raised by Shippon Parish Council not to infringe on the GREEN BELT Part 1 of the Plan which proposed using a small area of the GREEN BELT has been changed to cover a huge area of Dalton Barracks Airfield and also to remove Shippon Village from the GREEN BELT. So much for co-operation.
