The view of the local authority is that merely by putting the plans on the council website it is deemed that the electors of the vale of the White horse have been fully informed. I believe this is not the case where the technology exists to contact everybody within the file of the White horse and to inform them of the safeguarding of the land.

There has been no attempt to contact the landowners who are directly affected by the safeguarding of the land by the local authority.

Spurious bus and cycle routes have been safeguarded from Whitecross past south of Sunningwell through to the proposed Lodge Hill park-and-ride at the Diamond interchange. These routes have

been ploughed through open countryside which is within the greenbelt allocation around Oxford. It is obvious these roots have been placed to stymie any potential housing application from local landowners however by doing this you have blighted local properties for the next 14 years.

The Dalton barracks windfall should have led to a review of the housing policy in North Abingdon the Brownfield site has the potential for several thousand houses and this could have precluded the building of 1200 houses to the north of Dunmow Road from Copenhagen drive through to Peach Croft farm.

I believe the local authority has been negligent in not reviewing the housing policy in light of the Dalton barracks windfall.

Had such review been Undertaken then the siting of the Lodge Hill Park and ride and associated link roots would have led to a more thorough analysis of the development potential of the Brownfield site at Dalton barracks.

Undertaken then the siting of the Lodge Hill Park and ride and associated link roots would have led to a more thorough analysis of the development potential of the brownfield site at Dalton the barracks.

Instead of the local authority has ploughed on with previously agreed housing development and the percentage increase in the number of houses in North Abingdon is far too great to Be sustainable.

The Brownfield site at Dalton barracks is deemed to be approached with garden town principles and it is obvious that the park-and-ride and other amenities should be integrated within the confines of the current Dalton barracks site and links to the A34 and improvements to the bus routes would follow naturally from that location.

The housing allocations proposed are unsustainable and the highways improvements are not confirmed I believe the local authorities negligent in proposing the housing allocations before funding and roots are confirmed for the South Abingdon link road over the Thames from column and the Oxford to Cambridge Expressway and any changes improvements and alterations to the A34 main trunk road .

The Brownfield site at Dalton barracks should have a safeguarding area for a potential park-and-ride with access to the A34 trunk Road south and north. This will protect greenbelt land between Abingdon and Oxford preserving an important visual and environmental amenity .
