If you add up the proposed extra housing surrounding Didcot it is 5750 houses. Didoct is also expanding rapidly and has ambitious house-building plans. The roads cannot cope today. I know you expect to

improve some junctions but these tweaks are wholly inadequate. It will be impossible for all these people to get onto the A34, to use the A34, to get to the station or local schools during the 0730-0930 period (& other times).

The road to the station from the A34 needs dualling ALL the way (or Harwell & Didcot side roads will be become even more clogged as well).

Buses are not an option for mass transit until they are fast, frequent and have dedicated lanes (see London experience).
