No explanation has been given for the intended removal of five sites around Cumnor village, identified as 3,4,5,6 and 24, from the Green Belt.

Sites 4 and 5 lie within the Cumnor Conservation Area (CCA) and removing them from the designated Green Belt would serve no purpose – unless the intention is to legislate the CCA out of existence so that development of theses sites could then take place.

Site 3 lies right next to the A420 and its development (after removal from the Green Belt) would diminish the existing separation of Cumnor form the spreading urban sprawl of Botley which itself is part of an unbroken chain of development stretching to central Oxford.

The development of sites 5 and 6 would present insurmountable infrastructure problems, a fact recognised in recent planning decisions and removal of these sites from the Green belt would not correct these shortcomings.
