Cumnor is a small village with narrow roads including a a one way system. Traffic already grinds to a halt if there is parking outside the school or village shops and a lorry tries to pass as there is not room for both. Development of areas of Green Belt within the village would causes impossible traffic problems and present great risks to pedestrians including school children. The A34 (which will be used for travel to Harwell, site of anticipated jobs) is already saturated for much of the day as are the A420 and Oxford ring road. The village school is full and many current villagers have to send their children elsewhere as there is no capacity, necessitating car journeys, which clog up the roads. The schhol has no capacity to expand. The doctor's surgery has been in crisis for many years. Parking outside the local pub in Appleton Road reduces the road to a dangerous one lane on a blind corner on frequent occasions at weekends and in the evening.
