In general **Persimmon Homes** and **Taylor Wimpey UK Ltd** do not object to the overall approach to development in the Western Vale Sub-Area, where the lowest quantum of development is directed to reflect the relatively rural character of the area, and where development is predominantly required to support local services and facilities and/or to meet local needs. As in other locations however it is essential to fully assess and quantify (robustly) the actual <u>capacity</u> and <u>deliverability</u> of sites that are proposed for allocation. If the capacity of suggested sites has been over estimated there will be an overall shortfall, including in the first five year period, which should be made good by the allocation of additional land.

There is particular concern in respect of the **200** dwelling allocation directed to South West Faringdon, where the Landscape Capacity Study indicated that the <u>majority of the site is unsuitable</u> for development on landscape and visual grounds, with a maximum capacity of **115** homes. It seems to us that in this location, potentially together with some other sites, the Council has been overly optimistic in respect of the potential site capacity, thereby ensuring that the sites can meet the **200** unit threshold set (for strategic site allocations) and possibly to also minimise the total number of sites that have been identified. In the case of South West Faringdon an area almost twice the size of that suggested in the Landscape Capacity Study has been proposed and it is very unlikely that **200** units would be achieved on this area.
