3. A contribution is required to enhance public transport services to secure an hourly daytime service to Abingdon, Cumnor and Oxford and a service on Sundays and in the evenings

4. With regard to flood risk reference should be added to ensure that development of the site does not increase the likelihood of flooding either upstream or downstream of the current watercourses.
