Policy CP30 is very positive and the University strongly supports its wording, which recognises the importance of further and higher education both to the local economy

and ensuring that the work force is equipped to take advantage of the opportunities likely to arise in the future.

However, the University objects to the wording in paragraph 6.41, which indicates that a different approach is being taken to Oxford Brookes University's Harcourt Hill Campus to that being taken to the Cranfield University (Defence Academy) at Watchfield.

In relation to Oxford Brookes University's Harcourt Hill Campus the text states that: *'Improvements to the Oxford Brookes University Harcourt Hill Campus are specifically supported by Core policy 9.'* By contrast the wording in relation to the Cranfield University site at Watchfield is that *'the Council will support, where appropriate, the **development and expansion** of higher education facilities at Cranfield University (Defence Academy) at Watchfield.'*

The same approach should be taken to both Universities as Policy CP30 explicitly states that *'The most appropriate locations for further and higher education are: i) by the extension or more intensive use of existing education or other suitable community facilities.'* It is considered therefore that the more positive wording used for the Cranfield University site at Watchfield should be used for both institutions This would ensure compliance with the NPPF's aspiration *'that the planning system does everything it can do to support sustainable economic growth.'* (para 19)

Unless the text is revised to make it clear that there is scope for Oxford Brookes University to extend or make more intensive use of its Harcourt Hill Campus it would be incapable of complying with policy CP30 clause (i) so this policy will not be deliverable and there will also be a conflict within the plan, making it fundamentally unsound.

This will ensure that the same approach is taken to both higher education institutions and that Oxford Brookes University is able to implement policy CP30 as set out in more detail in the response to question 5.
