The Strategic Housing Market Assessment (SHMA) is unsound and set at a level which is unsustainable. It is based on unrealistic estimates of economic growth and extremely optimistic assumptions of future

needs provided by businesses. The total was seemingly presented as unarguable but is now seen to be over-estimated by a likely factor of 2-3. It appears that the consultation process did not go into sufficient depth, expert advice has been ignored and historical evidence has not been taken into account.

The idea of a major science and business corridor between Newbury and Oxford has been promoted for over 20 years, but has never taken off. Recent new buildings on the Harwell site, for example, where many of the new jobs are expected to be, have been used as holding or consultation offices by companies which have moved on after one year. Large-scale science budgets are suffering from severe and repeated cuts, so new job opportunities in those areas will be limited. There have been (privately owned) boarded-up houses on the Harwell site for a number of years. It may be that the present initiatives will be successful, but proposing housing at a distance from these sites, with an inadequate road network and limited public transport system, does not seem a practical way of meeting needs.
