The planned housing development would add to the already unacceptable level of traffic in and around this market town and even more gravely would add to the **level of pollution** which has **already** been officially recognised as **above acceptable limits**.

At the meeting held in summer at Long Furlong Community Centre with Councillor Sandy Lovatt, both community halls were packed to capacity with standing room only and every single person in attendance unanimously objected to these proposals. This is indicative of the strength of feeling these poor and unsound proposals have generated.
