The proposed development of 1000 new houses in Abindon North & North West will dramatically worsen existing traffic congestion; it will likely cause an increase of around 1500 cars using Dunmore Road, which is already a bottleneck during the rush-hour. We already have difficulty pulling out of our estate onto the Dunmore Road due to the amount of traffic, and several accidents have already taken

place, including two fatalities of local school children. The proposed development is adjacent to the A34 which is already the sixth most congested road in the country. Putting up to an additional 1500 cars on to this stretch of road would have a serious detrimental impact on traffic flows during the morning and evening rush hours. This would adversely impact not only local traffic but also through traffic on a major national artery with all the inherent economic implications.

The district council has now revised its original plan to include a much needed upgrade to the Lodge Hill interchange. This needs to be completed to reduce traffic congestion in Abingdon to levels which can sustain the existing level of build far less any new proposed development.

The proposed plan would make the traffic congestion even worse and should not go ahead.
