The simple re design of the double roundabout system would easily reduce congestion and increase traffic flow. South Abingdon would then according to the rationale of the Plan be suitable for some development reducing the impact on North Abingdon.

I regularly travel North, South Abingdon and town centre. It is wrong to suggest that South Abingdon is any worse or alone in suffering heavy traffic congestion.

The narrowing of 2 lanes down to 1 at the junction of Dunmore Road and Wooton Road roundabout on the North Abingdon peripheral road has caused further traffic congestion.

The bizarre and dangerous new roundabout layout does everything to cause further congestion. This redesign of the roundabout cost over a quarter of a million pounds and is widely regarded as a complete waste of public money. It is irrelevant to the community who is at fault with this but it does prove that the Vale do not have control over all their intentions. The Vale has agreed that the roundabout will have to be redesigned again at a further very costly and unnecessary expense to the taxpayer. This is not a good example of how the Vale can implement the Local Plan.
