I also cannot understand how a large increase in agricultral jobs is going to happen when solar farms are replacing a lot of the existing farm land?

If the jobs figures are incorrect, then the whole basis for the new houses is invalid.

In addition, the jobs figures are based on 2011 estimates I gather. If so then do they actual track with the current employment levels in the vale?
