Re VWHDC meeting of 15 October 2014. I attended this meeting and was appalled by the absence of democracy. I along with other village residents read our questions to the council. They had demanded to receive copies of these questions in advance so they could prepare their answers. What astounded me was that we were not allowed to reply. I object strongly to their proposal to put 1,400 houses on an AONB next to our small village (Chilton OX110RT) and suggested an alternative site, between Drayton , Steventon and Hanney. Some councillor replied saying that this land is liable to flooding. This is total rot. The land is flat, boring and not of any special interest , indeed had been suggested in the past as a possible site for a reservoir and even an airport runway. It is quite obvious that this land could be drained and save losing an AONB. The Dutch reclaimed the sea!! Are we that incapable that we can't drain the land with ditches?

I am clearly not alone in believing this to be an obvious site.

I believe that the Tories gang together to protect their own and totally ignore the wishes of their constituents.

At this meeting every one of the Conservatives voted in favour of dumping these houses on Chilton, even Mrs Margaret Turner and Mr Reg Waite ,(our District Councillors) and also Mr Stewart Lilly (our County Councillor). It is noteworthy that none of these live in Chilton and they don't seem to care except at election time. I have voted for many years for the Conservative party but that will now change.

There seems to be no integrity . Chilton residents collected a petition of 361 signatures objecting to the plan and the VWHDC only recorded it as one single objection.

Where is the justice? Are our representatives stupid or are they crooks?

We do need your help to retain our AONB . We don't need their houses.
