Identification of East Hanney as a 'Larger Village'

The strategic allocation of [around] 200 new homes at East Hanney seems to depend significantly on the 'classification' of East Hanney as a 'Larger Village'. This, in turn, is based on a quasi-quantitative ranking of the facilities, services and amenities attributed to the village. The truth is that East Hanney is a small community with limited services that are not a basis for a greater than 60% increase in the number of dwellings. Residents rely heavily on services in Grove, Wantage and, for example, Abingdon. The village shop is rudimentary and is staffed by volunteers – it does not even compare to the shop in Ardington – and there are no facilities for young people and families apart from a playground. The mobile library service will soon be lost and, if the village was ranked again, it would fall into the 'Smaller Village' category.

10 Villages with populations greater than East Hanney and with a facilities score either the same as or higher than East Hanney have NOT been earmarked for development. One village in the Vale that received a facilities score significantly in excess of that attributed to East Hanney and has over 1,000 homes has only been allocated a development site for 220 houses, increasing the total number of homes by just 22%. Compare this with the ~60% increase in homes proposed for East Hanney.

The assessment process used which classifies East Hanney as a settlement which should attract a strategic housing allocation is flawed and the Plan is, therefore, unsound.
