Placing housing to the North/north-west of Abingdon when the main employment opportunities are to the south of the town will place additional stresses on the road network; the distances are such that

walking and cycling are not really an option; bus do not serve these routes. The vulnerability of A34 and lack of alternative routes leads to severe congestion at peak times, and at other times if there is an incident on it. Increased traffic through Abingdon to Culham Science Centre, and round the orbital road will increase air pollution in the town. Pathways and cycle routes will be needed to promote walking and cycling within the community. The necessary crossings will cause further problems for traffic flow on the orbital road of Abingdon and Lodge Hill (which is very difficult to cross? witness the recent fatality here). Recent changes to a roundabout and junction on the Abingdon ring road to improve safety have made congestion worse: further development will increase traffic and need even greater safety precautions which will further exacerbate congestion
