The Vale's uncritical acceptance of the SHMA figures as targets has led to the inappropriate allocation of sites within the North Wessex Downs Area of Outstanding Natural Beauty (AONB). The plan has identified four sites in the Green Belt to accommodate 1,510 houses, and two in the AONB for a total of 1,400 houses, which is threatening to undermine the rural character of the Vale.

Under the Countryside and Rights of Way Act 2000 the Council has a statutory duty to have regard for the purposes for which the North Wessex Downs were designated an AONB, that is to conserve

and enhance the natural beauty of the landscape. The proposed development will in my opinion destroy it.

The NPPF (paras 115 and 116) places AONBs in the highest category of landscape protection and affords them 'great weight' in the decision-making process. Further to this the NPPF confirms that AONBs are one location where restrictions apply to development and accordingly that: 'Planning permission should be refused for major developments in these designated areas except in **exceptional circumstances and where it can be demonstrated they are in the public interest** .'

There is no evidence to demonstrate "exceptional circumstances", or that the allocations in the AONB are in the public interest. They seem to me to be in the very opposite of the public interest.

In the various landscape assessments of the AONB sites, there is no evidence of 'great weight' being applied to AONB characteristics when evaluating the selection of sites.

1. Remove the Harwell Campus East site from the plan.
2. Limit the housing allocation at the north end of the Campus to land within the existing campus, and remove the extension into greenfield land in East Hendred Parish.
