The SMHA is unsound and unsustainable. There is little evidence to suggest the figures are robust. The only analysis we have seen of the plan (by the CPRE) suggest the SMHA figures are grossly

inflated (being 2.5 times the Government?s official projections) and based on unrealistic economic growth. This critique of the SMHA was undertaken by a leading planning expert.

The SMHA makes many dubious adjustments to the official statistics which add over 20,000 houses to its forecast of need for Oxfordshire. There also appears to be a link to the number of new jobs to be created in the county. Again these figures appear unsound and lacking in any thorough scrutiny.
