To make Core Policy 15 sound, in terms of being 'justified' against Paragraph 182 of the NPPF, the housing supply table incorporated within the policy should state the following number of dwellings for Valley Park, within the South East Vale Sub-Area: "At least 2,550" (i.e. words "at least" should be added to this number of dwellings). It would also be more positive if a reference could be made to the fact that the site has significantly more capacity than 2,550, albeit some of this may fall outside the plan period. This will allow for a more comprehensive proposal for the site, with a better recognition of infrastructure provision.

This alteration would bring the policy in line with the Council's evidence base, as well as in line with the Development Template to which the policy refers.
