The safeguarded land for the Southern Didcot Bypass should be removed. Instead, an indicative link towards the land south of Great Western Park should be shown, allowing the Valley Park development to be linked to any future development south of Great Western Park. In addition, it may be more appropriate for any Didcot Southern Bypass – should it become a formal proposal – to link with the A417 junction to the south of the Harwell Strategic Link Road. Having such a major link running through the heart of the southern section of the Valley Park development will create significant severance. These modifications would remove that possibility.
